*MANGAL DISPENSARY IN BASUBA WARD*

Mr Speaker Sir, Pursuant to Standing Order 41(2)(C), I rise to seek a Statement from the Chairperson of the Departmental Committee on Health Services and Environment on regarding Mangal Dispensary in Basuba Ward.

Mr Speaker Sir, Article 43(1)(a) of the Constitution of Kenya, 2010 provide for the right to health care services.

Mr Speaker Sir, the people of Mangal are really suffering due to lack of access to health services . The nearest dispensary is at Kiangwi which is a distance of not less than 35km.

Mr Speaker Sir, Managai Dispensary was renovated and completed but lacks man power or nurse to run the center and this happened a long time ago.

Mr Speaker Sir, I seek to know the following from the Chairperson of the Departmental Committee on Health Services and Environment:-

1. What plans does the County Government of health have towards the said dispensary?
2. When will Mnagai dispensary be fully operational?
3. When will the County Government post a nurse and other medical necessities?
