**STATEMENTS***MANDA AIRPORT MATERNITY WING*

**MCA Atwaa Mohamed Salim (Shella):** Thank You Mr Speaker. Mr Speaker Sir, I rise Pursuant to Standing Order 41(2)(C), to seek a Statement from the Departmental Committee on Health Services, and Environment on matters pertaining to Manda airport maternity wing.

Mr Speaker Sir, as per Article 43(1)(a) of the Constitution of Kenya 2010, Every citizen has the right to the highest attainable standard of health, which includes the right to health care services, including reproductive health care. Taking note that newborn health is crucial and requires proper attention for the mother and child.

Mr Speaker Sir, it is a pity that the Manda airport maternity wing which is very essential to people of Manda has not been constructed despite the amount being budgeted in the FY 2023/24 and approved. Unfortunately, the financial year is coming to an end soon. The people of Manda are forced to travel to King Fahad to get maternity services.

Mr Speaker Sir, I seek to know from the Departmental Committee on Health Services and Environment on the following:-

1. Why is the maternity wing not constructed?
2. When will the maternity wing be constructed?
