Madam Speaker, I am aware that the duties of County Public Service Board is to employ, promote, demote, to terminate County Government Workers among other functions.

Madam Speaker , the Lamu County Public Service Board has employed the County workers on the following basis; some are permanent and pensionable, some are on contract, some are casuals.

Madam Speaker , I seek to know the following from the County Public Service Board through the Departmental Committee Chair Intergovernmental, Labour & Public Service on the following:-

1. Who are those employed on permanent and pensionable?
2. Who were employed on contracts and casuals
3. What are their job groups?

4. What is the mode of their payment?
5. The Board to submit a list of the same with all the details.

MCA Ahmed Hamid Omar (Nominated) : Thank you Madam Speaker, I stand to add on the statement that it will be good if we make a follow up of every employee of the Lamu County Government because there are employees who had been there for so long and they do not know when they will be taken as permanent and pensiable employee. It will also be good to get a clear picture on how these things are done by the County Public Service Board so that we can also make an assuarance to such people about their state.
