Further aware that the Ministry of Education in collaboration with the County Governments and other stakeholders has developed standard guidelines to operationalize National Pre Primary Education Policy

2017. The guidelines are aligned to the National Policy Framework for reforming Education and Training in Kenya (2012) and the Basic Education Act 2013.

Concerned that the policy provides in section 4.3.2.(g) that the County Governments should provide capitation grants to allow the ECDE centres to purchase the instructional materials per the institution enrolment which has never happened in our county.

Further concerned that, strict adherence to the guidelines by all Pre-Primary service providers are expected to guarantee provision of quality education which shall enhance preparedness for primary education. This is imperative since holistic growth and development of all Kenyan children remains an urgent priority in the development agenda.

I therefore urge this Assembly to compel the County department of education to adhere to the National Policy and disburse capitation fund to all pre primaries in the County.
