**SUBJECT: UN-PROTECTED DOGS**

I beg to give the following Notice of Motion

**AWARE THAT**, dogs are roaming in Lamu town and in other areas of the County anyhow posing threats to the residents

**FURTHER AWARE**, According to the Animal Welfare Act, pets’ owners are required to provide their pets with proper care and attention, including adequate food, water and shelter. Failure to do so can result in legal consequences

**FURTHER NOTING THAT**, domestic animals and dog in particular must be registered and licensed. The farmers and other livestock owners may legally kill dogs that are chasing or

attacking their animals, and dog owners are typically responsible for any harm to the livestock

**COGNIZANT THAT**, the Fourth schedule of our Constitution 2010 outlines the roles of the two level of Governments in promoting animal welfare; the National Government is responsible for protection of wild animals in conservation areas while the County Governments are mandated to seeing the control and welfare of domestic animals

**CONCERNED THAT**, the residents are disturbed by the abandoned, roaming dogs in our towns fearing for bites and other disease transmissions.

**FURTHER CONCERNED THAT**, rabies and parvo -virus are spread by traditional dogs and in particular the un-vaccinated dogs causing a burden to the residents and the Department of health in overcoming the negative outcomes of dogs bite.

**I THEREFORE URGE THIS ASSEMBLY** to compel the county department of Fisheries, Blue Economy, Livestock and Cooperative Development to ensure all un-licensed, roaming dogs without owners in the streets to be arrested and fine be imposed to the owners
