**THE LAMU COUNTY AGRICULTURAL MECHANIZATION SERVICE  
BILL, 2025**

*Clerk-at-the-Table:* A bill for an Act of the County Assembly of Lamu to provide for the establishment of Agricultural Mechanization Services in Lamu County.

We are starting with part II, Establishment of Agricultural Mechanization Service.

Clause 4, Establishment of Lamu County Agricultural Mechanization Service.

*MCA Bwana Mohamed Bwana (Majority Leader):* Madam Chair, before clause 4, there is an amendment on the title itself that reads the title be amended by inserting the phrase 'and ownership' immediately after the word 'establishment' so as to read Establishment and Ownership of Agricultural Mechanization Service.

Part IV (2), there is another amendment to insert a phrase, consisting of machinery and equipment procured and owned by the County Government donated by donors or National Government.

*Chair:* I now propose that part II, the title be part of the bill as amended.

*(Question put and agreed upon)*

*Chair:* I now propose that part IV, (2) be part of the bill as amended.

*(Question put and agreed upon)*

*MCA Bwana Mohamed Bwana (Majority Leader):* Madam Chair, there is another amendment part IV (3), to insert a new clause which states that, 'All machinery and equipment shall remain the property of Lamu County Government.

5(g) insert a phrase 'and advise farmers on appropriate machines and equipment suitable for various farm operations' after the word mechanization.

5(i) insert the phrase "and carry out farm planning and lay out after the word infrastructure

5(J) delete the phrase "of the" before the word county

5(l) be amended by deleting the word "of" before the word any.

Addition of new Section (m) which reads, organizing and participating in ploughing context, field days, exhibitions and shows.

Addition of new Section (n) which reads, liaise with mechanization research organizations on margins technology.

Addition of new Section (o) which reads, continuous development, modification and testing of agricultural machines and mechanization technology to suit local conditions.

Addition of new Section (p) which reads, to offer mechanized soil and water conservation service including but not limited to; construction of small earth dams and water pumps, terracing, ripping, land levels, bush clearing and drainage works.

A new section 8(h) be inserted to read, on the first meeting of the Board, members will elect the Chairperson and the vice Chairperson amongst the non-public servants' members.
